## Development of medical informatics in Burundi

Until 2012: Depending on specific needs

- Parallel developments
- Little communication between development and implementation companies
- Lack of coordination
- Academic sector little involved
- No representation at the international level
- No research in the domain

# Performers

- Growing number of performers in the medical informatics field,
- However, very limited skills among health professionals,
- Need training (post-graduate, integration in the curriculum, certified short courses...)

# **Creation of the BHIA**

- On the occasion of an "Evening of Medical Informatics" event organized by one of IT Companies of Bujumbura;
- The participants noticed that Burundi's level of development in the field of ICT in general and medical informatics in particular is still insufficient;
- Need to create a framework for the exchange of information and experiences, promoting education and research in the field of medical informatics.

# The BHIA

- Nonprofit organization
- Implemented in September 2012
- 25 active members
- Member Profiles:

IT, electronics technicians, application experts Doctors, pharmacists, laboratory technicians, nurses Teachers in universities and colleges.

- Represent Burundi in Medical Informatics Appointements
- Prepare held in Bujumbura of the Pan African Conference of February 2017 in collaboration with HELINA;
- Develop stakeholder training projects in the field of computerization of the health sector.

### Role of BHIA

- Neutral forum for discussion and exchange of experiences;
- Scientific framework and reporting of applications of medical informatics and research advances in the field of ICT, for healthcare professionals, scientists, IT solutions development companies and authorities concerned;

#### Role of BHIA (following)

- Mediation: facilitates exchanges between health professionals on the one hand, and scientists specialized in the computer, representatives of research organizations, public authorities on the other.
- Contribute to the professional and ethical reflection that should accompany the development and implementation of regulations governing such automated processing of medical information;

### Role of BHIA (End)

- Link : Collaborates with scientific groups and associations with similar objectives and represents Burundi at international level particularly in HELINA and IMIA (International Medical Informatics Association).
- Training framework: To contribute to the training of health professionals, researchers, engineers, and technicians, medical informatics;

#### Lessons learned

#### • lessons:

- The field of medical informatics is attracting increasing public ,
- An association like this can do much to raise awareness of the benefits of computerization in the health sector,

#### challenges:

- Good cooperation with the Ministry of Health and possibly the Ministry of ICT is essential,
- > Mobilization of funds for the activities of the association .

- Partnerships with other organizations or associations with similar orientations;
- Technical and financial support by the Government and the technical and financial partners.
